Subject: Guidelines for implementation of Amendment No. 7 to IS 13428 : 2005, Packaged Natural Mineral Water

- 1. Amendment No. 7 to IS 13428 : 2005 has been published. The last date for implementation of the amendment is **18 March 2020**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause no.	Change
Clause 3.1.6	Addition of new clause for 'Natural Spring water'
Clause 6.4	Natural spring water shall comply with the requirements given in this standard as specified in 6.1, 6.2 and 6.3 except Total Dissolved Solids (TDS) content. TDS of natural spring water shall be not more than 750 mg/l.
Page 3, table 2, sl.no. (vi)	The requirement of zinc has been deleted.
Clause Clause 8.1 g)	To mention the following in capital letters BEST BEFORE(DATE/MONTH/YEAR); or BEST BEFOREDAYS OR MONTHS FROM THE DATE OF PACKAGING/MANUFACTURE (in capital letters);
Page 5, Annex A and Page 6, Annex A	The following list of referred Indian Standards have been substituted by the latest version/revisions: IS 3025 (Part 5), IS 3025 (Part 39), IS 4905, IS 5401 (Part 1), IS 5402, IS 10500, IS 12252, IS 14194 (Part 1), IS 14194 (Part 2), IS 15185, IS 15187, IS 15188, IS 15302 and IS 15303.

4. Consequent upon issuance of the amendment, existing SIT has been revised as Doc: SIT/ 13428/9 Jan 2020 which is being circulated separately.

- 5. All ROs/BOs are requested to ensure the implementation of the above guidelines by **18 March 2020**. BOs shall ensure that no Licences are under operation as per IS 13428 : 2005 without the amendment after **18 March 2020**.
- 6. The above guidelines come into force with immediate effect.
