Dear Sir,

As you are already aware, the 'Policy of Archiving' has been adopted by BIS to help the Technical Committees prioritize the review of Standards.

The Standards, which cannot be withdrawn, but have lost relevance due to diminishing use in the wake of onset of new products, processes or test methods, can be archived. Upon archiving, a mention to this effect will be made against that Standard in the database of published Standards so as to have an idea of its current status. This will enable the committee to focus on more important standards and also keep the window open for the stakeholders to point out if the review is required.

In this connection, the following standards are proposed to be archived:

- a) IS 10894 : 1984- Code of practice for lighting of educational Institutions
- b) IS 2672 : 1966- Code of practice for library lighting
- c) IS 4347 : 1967- Code of practice for hospital lighting
- d) IS 6665 : 1972- Code of practice for industrial lighting
