## **REGISTERED LEGAL NOTICE**

### **Reminder-I**

Date - 25/04/24

To,

P. S. Jewellers,  
Situating at 168, Sarrafa, Jawahar Chowk,  
Jhansi, Uttar Pradesh-284001

Under the instructions of my client MR. Avanish Kumar son of Sri Rajdeo Prasad, resident of House No. 225/3D/177, Pritam Nagar, Near Arvindo School, Prayagraj-211011, I have to serve upon you the following legal notice for compliance.

1. That my client has purchased jewellery i.e. Natth from your shop "P. S. Jewellers" (GST No.09ACUPA9209P1ZT) situated at 168, Sarrafa Jawahar Chowk, Jhansi, Uttar Pradesh on 26.02.2024.
2. That you have cheated my client and breaches the trust by selling the gold ornament/jewellery i.e. Natth which was without Hallmark.
3. That my client has purchased this gold ornament i.e. Natth for his wife for wearing in her brother's marriage with love and affection. That my client has purchased gold ornament i.e. Natth by his hard core earnest money.
4. That on 27.02.2024 when my clients brother-in-law asked him about the Hallmark, then my client searched about the Hallmark number. Even after searching for a long time my client did not found any Hallmark number in the gold ornament i.e. Natth.
5. That when my client's wife got to know about this, that the Natth was without Hallmark. Then my clients wife refuse to



wear the same. After knowing this my client's blood pressure risen up and my client got fainted in his house because this natth was purchased for his wife with love and affection.

6. That thereafter when my client got normal then my client had contacted you over phone but you have not answered properly again my client has fainted out.
7. That due to heat conversation with his wife my client did not attended his brother-in-law marriage. That still my relation between my client and his wife are not good. That by this incident my client has not still recovered.
8. That as per the guidelines issued by government of India that the selling of gold ornament without Hallmark is a punishable offence. That under Section 29 of Bureau of Indian Standards Act, 2016

29. (1) Any person who contravenes the provisions of section 11 or sub-section (1) of section 26 shall be punishable with fine which may extend to five lakh rupees.

(2) Any person who contravenes the provisions of sub-sections (6) or (8) of section 14 or section 15 shall be punishable with imprisonment for a term which may extend to one year or with fine which shall not be less than one lakh rupees, but may extend up to five times the value of goods or articles produced or sold or offered to be sold or affixed or applied with a Standard Mark including Hallmark, or with both: Provided that where the value of goods or articles produced or sold or offered to be sold cannot be determined, it shall be presumed that one year's production was in such contravention and the annual turnover in the previous financial year shall be taken as the value of goods or articles for such contravention

(3) Any person who contravenes the provisions of section 17 shall be punishable with imprisonment for a term which may extend up to two years or with fine which shall not be less than two lakh rupees for the first contravention and not be less than five lakh rupees for the second and subsequent contraventions, but may extend up to ten times the value of goods or



articles produced or sold or offered to be sold or affixed or applied with a Standard Mark, including Hallmark, or with both: Provided that where the value of goods or articles produced or sold or offered to be sold cannot be determined, it shall be presumed that one year's production was in such contravention and the annual turnover in the previous financial year shall be taken as the value of goods or articles for such contravention.

(4) The offence under sub-section (3) shall be cognizable.


That in view of the facts and circumstances stated here in above, I here by direct you to pay the compensation of Rs.50,00,000.00/- to my client for selling the gold ornament without Hallmark along-with compensation mental harassment which was caused and Rs.55,000.00/- towards this legal notice within a period of Fifteen days from date of receipt of this legal notice. part from the said complaint, my client may also take action against you for committing fraud, cheating and mischief, if advised. In the eventuality of filing a case against you, you shall be saddled with the cost of litigation as well.

0. That you are liable for interest and penalty, as above.

1. That in case you fail to comply the aforesaid legal notice my client shall initiate both criminal and civil proceedings against you. To take appropriate legal recourse seeking damages through the court of law.
