

PROTOTYPE AND ILLUSTRATIONS

Game Concept: "BIS World – Standardization Champions"

This online game could be designed as an interactive, knowledge-based challenge. Participants, including students, consumers, and the general public, take on various roles in ensuring product quality, safety, and standardization. The game focuses on aspects like Standardization, Conformity Assessment, and Testing.

Players can choose their role:



- Product Developer: Focuses on ensuring their product meets all standardization criteria.
- BIS Inspector: Goes through various industries to check if their products meet BIS standards.
- Consumer Advocate: Raises awareness among consumers about choosing BIS-certified products.
- Conformity Tester: Runs tests on products and gives conformity certificates.
- Each character has a different goal tied to the activities of BIS. As they progress through levels, they learn more about BIS standards and their real-world applications.
- Main Levels : Each level could simulate real-world scenarios:
- Level 1: Standardization in Action

Players pick a product (e.g., electrical appliance, food item, or toy) and must choose the correct BIS standards for manufacturing and safety.

Objective: Select the right standards before the product goes to market.

- Level 2: Conformity Assessment Race
 - Players (as BIS inspectors) need to inspect factories or stores and check if products meet BIS certification. The player faces time-bound challenges to assess conformity.

Objective: Award BIS certification to compliant products or factories.

•//Level 3: Consumer Awareness Campaign:

In this level, players take on the role of a consumer advocate. They must educate virtual customers about the importance of buying BIS-certified products.

Objective: Create the most engaging digital campaign that reaches the most people.

• Level 4: Testing Ground:
Players conduct tests on various products (e.g., testing strength of materials, food safety checks, etc.).
They must use BIS-approved methods to pass or reject products.

Objective: Correctly test and approve products before they hit the market.

Mini-Games:

- Product Testing Puzzle: A fun drag-and-drop puzzle where players have to match testing tools to products.
- Conformity Quiz: Rapid-fire quiz questions on various BIS standards, helping reinforce knowledge in an engaging format.

Features and Interactivity:

• Leaderboard: Encourages competition among students, general public, and consumers. Players who score high can be featured here, motivating engagement and awareness.

- Badges & Rewards: Players earn badges such as "Standardization Expert," "Conformity Master," and "BIS Champion" when they complete specific levels. They can also earn certificates of completion tied to BIS awareness.
- Educational Pop-Ups: At various points in the game, brief informative pop-ups will appear. For example, when selecting a standard, the game will provide a brief description of the standard's importance.

Illustrations and Prototypes

- Main Interface Concept: The central map of the game represents a bustling city where each building or factory symbolizes a particular industry. Players can click on the buildings to enter different levels, corresponding to standardization and conformity activities.
- Character Avatars: Each character (Product Developer, Inspector, Advocate, Tester) would have fun, animated avatars. Their designs could reflect their roles—e.g., the tester might have a clipboard and safety goggles, the inspector might carry a certification stamp, and the consumer advocate could have a megaphone.
- Testing Simulation: In a testing simulation, the player might be in a lab environment where they need to interact with machines, sliders, and dials to simulate real-life testing protocols.

FEASIBILITY

- The need for public awareness about BIS is significant, as many consumers and businesses are still unaware of the importance of quality standards and certifications. A website could be a valuable tool in educating the public, promoting consumer safety, and encouraging industries to adhere to BIS standards.


