1) The current ISO Standard has the following modifications from its previous version: a) The scope has been changed to cover also cellulose nanomaterials instead of only paper, board and pulps; b) A definition of cellulose nanomaterial, along with additional instructions for sampling, sample preparation, and incineration for cellulose nanomaterials have been incorporated; and c) Additional instructions are given on how to express results when a sample has low ash content.

Please examine the document and share your comments regarding further improvement in the document.
