- 2) The test method has been updated by allowing the commercially available Ross-Miles foam apparatus for measuring foaming power. In addition, the provision has been added of running the test at the relevant concentration at which the product is intended to work. The instruction has been added to note the Calcium to Magnesium molar ratio in the water being used in the preparation of sample solution.*
