1) *The main changes as compared to the previous version are as follows:*

- *In the revised draft, an attempt has been made to address the social aspect of sustainability in clause 3.1.2.2 by relating EPE indicators to any one or more aspects of sustainability i.e. environmental, social, and economic aspects. The 3-Dimensional categorization of EPE indicators may help in achieving UNSDGs in an efficient and faster way or at least will help in thinking in all directions.*
- *Addition of subclause 3.1.3 for setting out the EPE principles.*
- *Addition of subclause 3.2.2.6 to provide guidance for selecting sector-specific OPIs for comparison. (The knowledge of sector-specific OPIs may help in developing PCR and EPDs and will also help organizations to understand the scope of improvement)*
