The benefits of applying the ISO 14002 series can include: — enhancing environmental performance within specific environmental topic areas; — protecting the environment by preventing or mitigating adverse environmental impacts within specific environmental topic areas; mitigating the potential adverse effect of environmental conditions on the organization within specific environmental topic areas; — aligning the environmental management system with the organization's strategic direction, e.g. to support a specific environmental policy or organizational commitment*
