In addition, a variety of modelling choices and approaches are possible depending on the goal and scope of the assessment. The water footprint can be reported as a single value or as a profile of impact category indicator results. This document provides illustrative examples on the application of ISO 14046 to further enhance understanding of ISO 14046 and to facilitate its widespread application. This document provides illustrative examples of how to apply ISO 14046, in order to assess the water footprint of products, processes and organizations based on life cycle assessment.
