1) In this revision, the following modifications have been incorporated: a) The references clause is being updated; b) The terminology clause is being updated; c) Referred standards for the test methods have been updated, as the IS 1060 (Part 1) has been revised and the test methods have been split in various parts and sections covering the different tests; d) The procedure is being slightly modified advising drying of sample pieces to be done after separation; and e) The procedure for recut of fluting medium is being elaborated.
