- 1) This third revision has been undertaken to align the product standards with current market demands, enhancing its acceptance and relevance. Notable changes include:*
- 2) a) The test method for color difference, tinting strength, and ease of dispersion has been changed to the Vibro Shaker method, replacing the existing method based on Muller. The requirements have been accordingly modified to reflect this change; b) To address health and safety concerns, restrictions for lead and toxic heavy metals have been introduced; c) A suitable precautionary note has been added in the marking clause in order to prevent unforeseen events, and; d) Additionally, various editorial corrections, and references have been updated to ensure accuracy and relevance in the revised standards.*
