- 1) This standard IS 17900 Part 3/Section 2 covers the requirements for planning, installation of Goods Lifts and Automobile lifts in factories, warehouses buildings, shopping malls, data centers, mix use buildings, etc. The document permits the number and configuration of lifts and their main specifications to be determined at an early stage of building design, provided that the size and intended use of the building is known. It also gives guidance on the necessary dimensions to permit the installation of the lifts.*
- 2) This standard deals with electric and hydraulic lifts. It covers lifts with both horizontal and vertical power-operated sliding doors.*

Please examine the document and share your comments regarding further improvement in the document.
