1) *This Draft Indian standard deals with lifts specially designed and installed in or at a private home as a means of access for the residents of the home to the different levels, provided the lifts are so installed and operated that they are not accessible to the public or to other occupants of the building. In the case of home lifts, visitors will have limited access to the lifts in exceptional circumstances, only under the supervision of the residents of the private home. The residents of the private homes shall ensure that access to the home lift is protected from unauthorized use.*
