1) This part of IEC 61800 specifies electromagnetic compatibility (EMC) requirements for adjustable speed power drive systems (PDSs) and machine tools (MTs). A PDS is an AC or DC motor drive including an electronic converter. Requirements are stated for AC and DC PDSs and MTs with input and/or output voltages (line-to-line voltage), up to 35 kV AC RMS. This document applies to equipment of all power ratings.

Please examine the document and share your comments regarding further improvement in the document.
