Any other attachments agreed between the buyers and manufacturers are also covered within the scope of this standard provided it meets all the relevant requirements mentioned in the standard e.g blenders, food processer attachment etc. Multipurpose machines that are used together with certain accessories are also covered by this standard as far as it applies.
