*This document has following salient features which may require specific attention for your valuable comments:*

- 1) The standard was first published in 2011 as an identical adoption of ISO 14710 : 1996 'Equipment for crop protection — Air-assisted sprayers — Dimensions of nozzle swivel nuts'. However, the ISO standard has now been withdrawn. Considering the relevance of the standard in Indian context, the standard is being revised by converting it into an Indigenous Standard.*
- 2) This Indian Standard specifies the outer dimensions of the swivel nuts of nozzles for air-assisted sprayers.*

Please examine the document and share your comments regarding further improvement in the document.
