This document has following salient features which may require specific attention for your valuable comments:

- 1) Pedal-operated paddy threshers are mechanical devices operated by human power using pedals which are used to separate grain from the paddy straw.*
- 2) The pedal-operated paddy thresher consists mainly of a well-balanced cylinder with a series of threshing teeth fixed on slats and it is worked by a pedal and gear drive mechanism either in standing position or sitting position.*
- 3) This standard prescribes the material, dimensional and other requirements for the pedal-operated paddy thresher.*
