This document has following salient features which may require specific attention for your valuable comments:

Tractor operated trailers are used for transport of farm produce. This standard has been prepared for the guidance of manufacturers and purchasers in the production and selection of trailers of proper quality. This standard was first published in 1976 and subsequently revised in 1983 and 1987. The current revision (fourth) of the standard has been undertaken to incorporate following modifications:

a) Minimum capacity of balanced-trailer has been increased from 2 to 5 tonnes and range of 2 to 10 tonnes has been provided to cover all the models falling in this range.

b) Parking and service brakes requirement has been changed to recommendatory from obligatory.

c) Requirement of slow moving vehicle has been incorporated in the standard which was covered in IS 12239 (Part 2) : 1999 "Tractors and machinery for agriculture and forestry – Technical means for ensuring safety: Part 2 Tractors

(first revision)”

d) Dimensions of various components of axle assembly have been modified as per current manufacturing practices.
