While providing minimum specifications for LiDAR data acquisition it allows flexibility for stricter requirements based on project needs or research purposes.*

2) Highlights the standard's unique consideration for India's varied landscapes, including plains, Himalayas, forests, and monsoon. Underlines the allowance for stricter data collection beyond minimum specifications based on specific project demands. Acknowledges the standard's accommodation for specialized research projects with different data requirements. Mentions the standard's support for technical alternatives and professional consideration of innovative proposals.
