- 2) The preparatory work for this International Standard recommended five projects with the following titles: Addressing — Conceptual model; Addressing — Good practices for address assignment schemes; Addressing — Quality management for address data; Addressing — International postal address components and templates; Addressing — Address rendering for purposes other than mail.*
