This document has following salient features which may require specific attention for your valuable comments:

- 1) Smart cities generate a large amount of data that can benefit stakeholders such as providers, consumers, and governing agencies if used correctly. The proprietary nature of interfaces and implementations makes it difficult to exchange data efficiently in current smart cities. The Indian Standard IS 18003 (Part 1) Unified Data Exchange Architecture and IS 18003 (Part 2): API Specifications were developed to provide a standardized framework for accessing data and allowing authorized sharing among entities.
- 2) The Data Exchange (DX) layer comprises three services: Catalogue Service, Authorization Service, and Resource Access Service, with Catalogue Service being the data discovery plane. IS 18003 (Part 3): Compliance Specifications Sec-2 specifies the abstract test suite to ensure compliance with Catalogue Service as defined in IS 18003 (Part 2): API Specifications. Compliance specifications are divided into five sections: scope, normative and informative references, definitions, Catalogue Access Service functional profiles, and test details.

Please examine the document and share your comments regarding further improvement in the document.
