**Subject: Continuation of various temporary measures made in operation of product certification Scheme - I (SI) - reg.**

In view of the extraordinary situation arising due to COVID-19 pandemic in the country, various temporary measures have been made in the operation of product certification scheme - I.

- 2) The applicability of following temporary measures had been extended upto 30 Sept 2020 and informed vide circular Ref: CMD-I/18:5:9 dated 09 June 2020:
  - i) Renewal of licence after validity date without charging late fee
  - ii) Extension of time limit for deferred licence beyond 90 days
  - iii) Waiver of inspection fee in cases of re-visits to the factory for collection of fresh samples due to expiry of shelf life of samples etc.
  
- 3) Additionally, the applicability of following temporary measures have also been extended upto 30 Sept 2020:
  - i) Processing renewal of licence on self-declared production statement basis (vide circular Ref:CMD-I/2:12:3, dated 17 April 2020)
  - ii) Grant of licence on factory testing basis (vide circular Ref:CMD-I/2:12:1, dated 15 April 2020)
  - iii) Relaxation of guidelines for grant of licence (vide circular Ref:CMD-I/2:12:1, dated 03 April 2020)
  
- 4) The provision for deferment of licence informed to be kept in abeyance (Sr.No. 4-i)-a) of circular Ref:CMD-I/1:1:8, dated 30 March 2020) may now be exercised as per the guidelines for renewal of licence. The decision to renew the licence may be deferred upto 90 days from the date of validity or upto 30 Sept 2020 (whichever is later).
  
- 5) This issues with the approval of the competent authority.
