Subject: Issues regarding Grant of All India First licences

1. While processing All India First applications received from ROs/BOs, the following issues have come to notice of the undersigned by CMDs :
 - a. Branch Offices are recording and processing the applications against Indian Standards on All India First basis without properly examining the standards with respect to the various requirements and availability of testing facilities at BIS Labs/OSL/any other lab in the country or in-house.
 - b. In most Indian Standards (published in and after the 1990s), a clause (Clause 2) is present to the effect that the latest version of cross referred standards is to be considered. However, in case of older standards (published before 1990s), this clause does not exist and the version of cross-referred standards mentioned in the product standard, has either been revised or withdrawn and replaced with a new standard, for which no amendment has been brought to the product standard. Branch Offices are recording and processing such applications without examining such situations.
2. The above issues are observed at CMD during scrutiny of the red forms. This is creating problems and delays as the cases cannot be processed until all the provisions of the Indian Standard are complied with. In certain cases, standard has to be reviewed/amended/revised by the technical departments and it is taking lot of time and applications are kept on hold for GOL. Lot of representations are being received from the applicants seeking the status of the applications and expressing their displeasure in this regard. Hence it is proposed that such cases should be thoroughly examined by the BO at the first instance and applications be recorded only after obtaining the concurrence of the respective DDGRs.
