2. FSSAI, vide a circular dated 24 07 2020 has further extended the timeline for compliance with the direction dated 27 January 2020 on mandatory compliance of Compounded Feeds for cattle as per IS 2052 : 2009 upto **1<sup>st</sup> January, 2021**. (Copy of circular dated 24 07 2020 is enclosed).
3. BOs are advised to note the above direction of FSSAI for necessary action.



**Subject: Extension of timeline for compliance with the direction dated 27<sup>th</sup> January, 2020 issued under 16(5) of Food Safety and Standards Act, 2006 regarding compliance of commercial feeds/feed materials intended for meat and milk producing animals with relevant BIS standards.**

Reference is drawn to direction F. No. 1-95/Std/Misc/SP(L&C/A)/FSSAI-2015-Pt-1 dated 27<sup>th</sup> January, 2020 uploaded on FSSAI website on 29.01.2020, regarding compliance of the commercial feed intended for cattle with Bureau of Indian Standards (BIS) specifications for Compounded feeds for Cattle (Is 2052:2009) as amended on the date of enforcement of the direction and to carry a BIS certification mark on the product label. As per the direction, it will come into force after 6 months (i.e. July 27<sup>th</sup>, 2020) from the date of issue of the direction.

2. Meanwhile representations have been received requesting for further extension of time for compliance with the provisions of the above mentioned direction on account of the current COVID-19 pandemic and subsequent lockdown orders/restrictions issued by the Central/State Governments.
3. After due consideration of the representations, it has been decided to extend the timeline, for compliance of the provisions of the above mentioned direction further upto 1<sup>st</sup> January, 2021
4. This issues with the approval of the Competent Authority in exercise of the power vested under Section 16(5) of the Food Safety and Standards Act, 2006.
