This has reference to CMD-III circular of even no. dated 23 01 2018 on the subject mentioned above, permitting relaxation on testing of Electrical Capacitors for applications submitted under Simplified procedure.

2. Based on representations from the Industry, the Competent Authority has agreed to permit relaxations for applications received under Normal Procedure also. For such applications, the following relaxations on testing may be permitted:

A. The Applicant submits an in-house test report covering the following type tests:

IS 2993 – Endurance test, Damp heat test IS 13340 (Part 1) – Ageing test, Thermal Stability test IS 13585(Part 1) - Ageing test, Thermal Stability test **OR**

- B. The Applicant submits an Independent Test Report (not more than 1 year old) issued by a BIS recognized laboratory/ group-2 category Lab for the tests mentioned at A above.
- C. In case the Applicant complies with A or B above, Grant of Licence may be considered based on the results of other tests (of the Factory Sample drawn during PI) and without waiting for the results of the tests mentioned at A. Specific instructions for issue of partial TRs shall be suitably provided in the Test request. Adequate no. of samples shall also be drawn by the IO in such cases.
- D. An undertaking shall also be obtained from the Applicant on his letter-head that, in the event of failure of the sample in the above test(s), the licence, if granted shall be processed for cancellation.

3. The relaxations permitted under Simplified as well as the Normal Procedure shall now be considered for Applications/ Inclusion requests submitted on or before **31**st **December 2018.**

4. These guidelines have been approved by CA and shall come into force with immediate effect.
