# Sub: ITTAC Submission regarding relaxation in marking on tyres in view of situation raised due to lockdown

Representation has been received from Indian Tyre Technical Advisory Committee (ITTAC) to allow usage of Serial Number plates having Week and Year code of lock-down period which was available with the Industry before the start of lock-down period, for the production of tyres after lifting of lockdown citing that their vendors are not able to supply the serial number plates with current Week and Year code due to lockdown.

In this regard, following has been decided:-

- 1. Licensees may be permitted to use the marking plates with old week and year / month and year code available with the Industry before the start of lock-down period. Such relaxation may be permitted for production of 30 days after lifting of the lockdown or up to which the factories are expected to get the marking plates with current week marking, whichever is earlier.
- 2. It may be made clear that after expiry of 30 days from lockdown or the date from which the licensee is able to get fresh serial number plates, whichever is earlier, every product shall be marked with the week code of actual production.
- 3. To ensure traceability of all ISI marked products, licensee should maintain records of production and testing as per relevant SIT. While maintaining the records, both the current week no/month of production as well as the actual marked week/month along with the serial number of the tyre (if marked on the tyre), shall be mentioned. A separate remarks column may be added to indicate that all such production was made during "---" week but marked with "---" week due to lockdown.
- 4. While using old week marking plates in place of current week marking plates, it should be ensured that the week number which was used for the production before lockdown shall, in any case, not be used again for the productions made after lockdown so as to ensure any sort of confusion on traceability.
- 5. Licensee may be advised to submit an undertaking to the effect that he shall maintain proper records of all such production with such marking. Licensee may also be advised to inform total number of tyres marked in this manner to respective Branch Offices. Licensee should further undertake that he shall be solely responsible for traceability of all products including those marked with old week code in place of current week code.
