Subject: Temporary measures for relaxation of guidelines for Grant of Licence (GoL) as per conformity assessment Scheme - I ( ) - reg.

Bureau of Indian Standards (BIS) is operating product certification scheme to grant licence for use of Standard Mark ( so per Scheme - I of BIS (Conformity Assessment) Regulations, 2018.

- 2. The general principle for GoL is successful assessment of the manufacturing infrastructure, production process, quality control and testing capabilities of a manufacturer through a visit to its manufacturing premises. Conformity of the product to the relevant standard(s) is also established through third party laboratory testing or testing in the manufacturing premises or a combination of both.
- 3. As per Sr. No. 7-b) of guidelines for GoL Ref: CMD-I/2:12:1 dated 29 April 2019, under Option 2, the applicant is required to submit the proof of delivery of the sample drawn during the factory visit to the concerned laboratory, wherever applicable, and the testing fee. Only after submission of such proof, the licence is to be granted by the competent authority.
- 4. Due to the prevalent extraordinary situation of lockdown declared by the Central Government for containment of COVID-19 spread, operational difficulties have been expressed by ROs/BOs in processing the cases for GoL such as:
  - i) In some of the cases where verification visits for applicants have been recently done and samples couldn't be deposited by the manufacturer to the designated lab as per above guidelines. Again there are two situations:
    - a) One, where sample(s) can be deposited and tested by the lab after lifting of lockdown.
    - b) Second, where sample has a limited shelf life or is required to be tested after a particular time (Like testing on 28th day in case of Paver Block as per IS 15658) by the laboratory.
  - ii) Based on the issues raised by the heads of BIS labs during a meeting with DG, it was also felt that some of the samples which have reached the laboratory or are under test, the labs may also not be able to test the samples with above mentioned issues of shelf life or specific date of testing.
- 5. To address the above issues, following temporary relaxation measures in the Guidelines for GoL Ref: CMD-I/2:12:1 dated 29 April 2019 are issued:

- i) Verification samples which have not been deposited in the designated laboratories by the applicant manufacturers may be allowed to be deposited for testing within 30 days after lifting of the lockdown restrictions subject to applicant submitting an "Undertaking" as per **Annexure I**. The application may be processed for GoL based on the Undertaking submitted subject to fulfilment of all other requirements as per Regulations & Guidelines. In case of non-compliance of this undertaking by the manufacturer after lifting of lockdown, licence may be processed for cancellation.
- ii) For samples with issues like testing at particular time/day, limited shelf life etc. may require drawl of fresh sample(s). In such cases an Undertaking as per **Annexure II** shall be taken from applicants for facilitating visit by BIS (an early surveillance visit preferably within one month), drawl of fresh samples and timely deposition of samples in laboratory after lifting of lockdown. The fresh samples drawn shall be treated as a verification sample. The application may be processed for grant of licence based on the Undertaking submitted subject to fulfilment of all other requirements as per Regulations & Guidelines. In case of non-compliance of this undertaking by the manufacturer after lifting of lockdown, licence may be processed for cancellation.
- iii) The above relaxations shall be applicable for visits carried out between 01 March 2020 and date of start of lockdown. Applicants will have the right to opt for these relaxations. If an applicant doesn't opt for availing the relaxation, the application shall be kept pending as per the established guidelines.
- iv) For cases at Sr. No. 4 ii) above, after receipt of confirmation from the labs that they had not been able to undertake testing of the samples, surveillance inspection shall be arranged by the BO Heads for drawl of fresh samples for all such licences preferably within one month. BO Heads shall proactively take up with labs to get the status of testing in all such anticipated cases.
- v) DDGRs shall ensure close monitoring of all such cases in their regions.
- 6. This issues with the approval of the competent authority.
