Subject: Acceptance of Test Reports under Simplified Procedure - reg.

1. This is with reference to the Guidelines on Simplified Procedure issued vide CMD-1/2:4:1 dated 09 June 2016 and subsequently amended vide CMD-1/2:4:1 dated 31 May 2017.

2. Time period for acceptance of Test Reports has been specified under Si. No. 4 of the said guidelines as given below:

"The test reports of the product shall not be more than 45 days old. The period for counting 45 days shall be from the date of issue of the test reports to the date of receipt of the application in the BO. Test reports up to 60 days old may be accepted with justification for which the Head BO shall record the justification. In case of multiple test reports for one product, the latest product test report shall not be more than 45 days old and the oldest product test report shall not be more than 90 days old."

3. It is felt that there may be genuine reasons for not submitting the test reports of a sample within the specified time norms as per the simplified procedure by the applicant/licensee.

Accordingly, the following may be considered by the BOs with regard to acceptance of test reports under simplified procedure:

"If a BO is of the opinion that the test report(s) to be considered for Grant of Licence/Inclusion of varieties under simplified procedure (refer CMD-1/2:4:1 dated 09 June 2016 and subsequently amended vide CMD-1/2:4:1 dated 31 May 2017) need to be accepted beyond specified time norms due to genuine reasons, the case may be put up for the approval of concerned DDGR with proper justification. DDGR after due consideration of the facts in the recorded justification, may take a decision whether to allow acceptance of the test report(s) which are not within the time limits specified at SI. No. 4 of the simplified procedure."
