### Subject: BIS (Conformity Assessment) Regulations, 2018 – Provisions for Product Certification scheme

1. BIS (Conformity Assessment) Regulations 2018 under the provisions of BIS Act 2016 have been notified as already circulated by Bureau Sectt.
2. Product Certification Scheme being operated by BIS is now governed by the provisions specified in BIS Act 2016, BIS Rules 2017 and BIS (Conformity Assessment) Regulations 2018. Provisions of Regulation 4 to Regulation 11 and **Scheme - I (including Annexures and Forms) of Schedule - II** of BIS (Conformity Assessment) Regulations 2018 are specifically applicable to the product certification scheme for grant of licence.
3. Some of the salient provisions to be taken note of specifically with respect to provision of fee and period of validity of licence applicable under Scheme - I of BIS (Conformity Assessment) Regulations 2018 are listed below:
  - i) Provision of late fee of rupees five thousand if the renewal application is made after the validity of the licence.
  - ii) Provision of fee of an amount of rupees five thousand shall be chargeable per variety or, where grouping guidelines are available, per group of varieties in case of extension of scope of licence,
  - iii) Provision of inspection fee at the rate of rupees ten thousand per day, when test certificate based on pre-dispatch inspection is required to be issued,
  - iv) Provision of testing fee of samples to be borne by the applicant or the licensee, for samples other than those which may be drawn during surveillance or complaint investigation.
  - v) Provision to grant the licence for not less than one year and upto two years.
  - vi) Provision to renew the licence for a further period of not less than one year and up to five years.
4. Various forms attached to Scheme - I of Schedule – II are required to be used by all RO/BOs.
