Subject: Relaxation in Fee for MSME units for Licence under BIS (Conformity Assessment) Regulations, 2018.

In view of the extra ordinary situation in the country due to lockdown and to lessen the financial burden for MSME manufacturers holding or seeking BIS licence in the country, following relaxations in fee for both the grant of licence and renewal of a licence under Scheme - I of BIS (Conformity Assessment) Regulations, 2018 are provided to MSME units during 2020-21:

- i) Additional rebate of 20% on Minimum Marking Fee for the year 2020-21 on the applicable fee for one-year validity as notified in BIS (Conformity Assessment) Regulations, 2018 (as amended) for all the new applications and renewal applications. (For example: If Minimum Marking fee for a product is Rs. 37000/- for MSME licence, a rebate of 20% i.e. Rs. 7400/- will be applicable for all MSME licence for the product.)
- ii) a) Option to submit the minimum marking fee in two half-yearly equal instalments i.e. first instalment at the time of grant or renewal of licence itself and second instalment within six months from the date (Validity Date) of grant or renewal of licence. In case of opting for payment in two instalments, an undertaking will be required to be submitted by the MSME manufacturer as per **Annexure 1 or Annexure 2**, as applicable.
 - b) If the manufacturer doesn't pay the second instalment of marking fee within stipulated period of 6 months, the licence shall be put under suspension as per the provision of subparagraph (6) of paragraph 11 of Scheme I of BIS (Conformity Assessment) Regulations, 2018. As per this provision, the notice of 21 days shall be served by the concerned Branch office (BO) of BIS to the manufacturer twenty-one days before the last date permissible for payment of second instalment.
 - c) The suspension may be revoked on receipt of the second instalment as per provision of subparagraph (7) of paragraph 11 of Scheme I of BIS (Conformity Assessment) Regulations, 2018. However, for any delay beyond the period of six months admissible under this relaxation, a late fee of ₹ 5000/- (+ applicable Taxes) shall be payable by the manufacturer.
 - d) If manufacturer doesn't pay the second instalment even after imposition of suspension and the manufacturer doesn't submit the amount due till the next renewal, the subsequent renewal shall be considered only after submission of all pending dues including late fee along with fresh fee applicable.
 - e) In case a manufacturer doesn't apply for renewal of licence subsequently, the amount due with late fee shall continue to be payable by the manufacturer to the Bureau. The Bureau shall take appropriate legal actions to seek recovery of such dues from the manufacturer.
- iii) A rebate of 20% on Inspection fee for the year 2020-21 on the applicable inspection fee of ₹ 7000/- as notified in sub-paragraph (6) of paragraph 5 of Scheme I of BIS (Conformity Assessment) Regulations, 2018.

iv) As notified in sub-paragraph (5) of paragraph 5 of Scheme I per BIS (Conformity Assessment) Regulations, 2018, in case of extension of scope of licence, an amount of rupees five thousand is chargeable per variety or per group of varieties, where grouping guidelines are available.

The amount of ₹ 5000/- shall be charged on single inclusion request irrespective of number of varieties requested in the extension of scope during 2020-21.

- v) The above relaxations shall be applicable for grant or renewal of licence for one year validity during the period of 2020-21.
- vi) For the licence already granted or renewed during 2020-21 (such as during April & May 2020), the above additional rebate in minimum marking fee will be given at the time of next renewal.
- **2.** Relaxations already given to Industry for Licence under Scheme I: BIS has already taken measures to ease out the difficulties of industry by giving temporary relaxation in the provisions of BIS (Conformity Assessment) Regulation 2018 & Guidelines regarding process of grant and renewal of licence as given below. The relaxations include:
 - i) Renewal of licence after validity date without charging late fee during lockdown and 30 days after lifting of lockdown.(vide Circular no. CMD-I/1:1:18, dated 30 March 2020)
 - ii) Extension of time limit for deferred licence beyond 90 days during lockdown and 30 days after lifting of lockdown. (vide Circular no. CMD-I/1:1:18, dated 30 March 2020)
 - **iii**) Waiver of inspection fee in case of re-visits to the factory for collection of fresh samples due to expiry of shelf life of samples etc.(vide Circular No.CMD-I/18:5:9, dated 23 April 2020)

The applicability of above relaxations is extended up to 30 Sept. 2020 instead of 30 days after lifting of lockdown.
