Subject: Guidelines for implementation of Amendment No. 1 to IS 7903:2017 – Textiles – Tarpaulins made from High Density Polyethylene (HDPE) Woven Fabrics

- 1. Amendment No. 1 to IS 7903:2017 has been published. The last date for implementation of the amendment is **2 July 2019**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Requirement
5.1.1	Unit of measurement of coating thickness of lamination has been changed from "im" to "micron"
5.1.2	Minimum thickness of sandwich lamination has been changed from 40 "mm" to 40 "micron"
5.3	Overlap of joint/seam was specified as 3.5 cm which has been changed to 35 mm (Editorial change)

- 4. There are no changes in the existing SIT as the changes are typographical in nature.
- 5. The guidelines for implementation of the amendment is given below:

#### A. LICENSEES:

(i) All Licensees shall implement the amendment by **2 July 2019**.

#### **B. APPLICATIONS FOR GRANT OF LICENCE:**

(i) Applications which are recorded henceforth may be processed with consideration of the amendment. Beyond 2 July 2019 no Licence shall be granted without consideration of the amendment.

#### C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- 6. The above guidelines come into force with immediate effect.
