**Subject: Guidelines for Implementation of amendment no. 1 to IS 10508:2007  
(Phosphoric Acid, Food Grade)**

1. Amendment No. 1 to IS 10508:2007 has been published. The amendment is to be implemented **with immediate effect**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Changes
Foreword, 4.3 (j)- Marking Clause	“Food Safety and Standards Act, 2006” has been substituted for “Prevention of Food Adulteration Rules, 1955” and “Legal Metrology Act, 2009” substituted for “Standard of Weights and Measures (Packaged Commodities) Rules 1977”
2	Reference standard for Food hygiene has been updated (IS 2491:2013)

4. Consequent upon issuance of the amendment, there is no change in existing STI.
5. The guidelines for implementation of the amendment is given below:

**A. Licensees:**

- (i) All Licensees shall implement the amendment with immediate effect. BOs shall ensure that no Licences are under operation as per IS without the amendment.

**B. Applications for Grant of Licence:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed only with consideration of the amendment.
- (iii) No Licence shall be granted without consideration of the amendment henceforth.

6. The above guidelines come into force with immediate effect.
