Subject: Guidelines for Implementation of amendment no. 6 to IS 9523:2000 (Ductile iron fittings for pressure pipes for water, gas and sewage)

- 1. Amendment No. 6 to IS 9523:2000 has been published. The amendment is to be implemented **with immediate effect**.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Changes
4.1	The original clause specified that the material used for manufacture of casting shall conform to the appropriate grade of IS 1865. However, in this amendment the reference to IS 1865 has been removed and the method of manufacture has been left to the discretion of manufacturer.

- 4. Consequent upon issuance of the amendment, there is no change in existing STI.
- 5. The guidelines for implementation of the amendment is given below:

A. Licensees:

(i) All Licensees shall implement the amendment with immediate effect. BOs shall ensure that no Licences are under operation as per IS without the amendment.

B. Applications for Grant of Licence:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed only with consideration of the amendment.
- (iii) No Licence shall be granted without consideration of the amendment henceforth.
- 6. The above guidelines come into force with immediate effect.
