Subject: Guidelines for Implementation of revised IS 1848 (Part 1): 2018 and revised IS 1848 (Part 2):2018

- 1. IS 1848:2007 has been revised as IS 1848 (Part 1): 2018 and IS 1848 (Part 2):2018 and has been published. The last date for implementation of the revised Standards is **4 June 2019** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard.
- 3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Changes
1.0	Existing IS 1848:2007 which contained 19 varieties of papers, has been split into two parts based on application of varieties of writing and printing paper:
	i) IS 1848 (Part 1):2018 covers: account book, azure laid, bond, cream laid and cream wove/printing white/printing coloured/printing offset, Printing maplitho, Printing white super calendered and typewriting varieties of writing and printing papers
	ii) IS 1848 (Part 2): 2018 covers: Air mail/manifold, Cartridge drawing, Cartridge white, Duplicating absorbent and duplicating semiabsorbent, and Poster machine glazed varieties of writing and printing papers.
4	The amendments have been amalgamated and requirements have been modified and upgraded in this revised edition
4.1	The requirement of mechanical pulp has been made more stringent by reducing its limit
4.2	The clause for selection of sample size for determination of substance has been modified
4.5	The requirement of pH has been modified
2	References of latest available test method standards have also been made in this standard
1.0	Some of the varieties which are not at all being used have been removed

- Consequent upon the issuance of the revised Standard, existing STI is being revised to new Schemes of Testing and Inspection (SITs) for the revised standards and will be circulated shortly.
- 5. The guidelines for implementation of the revised Standard is given below:

A. Licensees:

- (i) All Licensees shall implement the revised Standards by **4 June 2019**. BOs shall ensure that no Licences are under operation as per the old Standard after **4 June 2019**.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of additional facilities, if any, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions by **4 June 2019** it shall be dealt with as per the prevailing guidelines.

B. Applications for Grant of Licence:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised Standard, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **4 May 2019** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **4 June 2019**.
- (iii) Beyond 4 June 2019 no Licence shall be granted as per the old Standard.

C. Change in Scope of Licence:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **4 June 2019** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
