# Subject : Guidelines for implementation of IS 16892:2018 which has superseded IS 14613:1998

- 1. This reference to the subject mentioned above.
- IS 16892:2018 has been published and notified vide Gazette Notification S.O. 4650 dated 27.11.2018, IS 16892:2018 Sattu has superseded IS 14613:1998, Chana Sattu. The last date for implementation of IS 16892:2018, is 25 04 2019 after which IS 14613:1998 shall stand withdrawn.
- 3. As per manakonline, there is 1 licence in operation for IS 14613:1998.
- 4. Significant changes observed in the new standard as listed in table below:

- 5. Consequent upon the issuance of the revised Standard, existing STI is being revised as Scheme of Inspection and Testing and shall be put up shortly.
- 6. The guidelines for implementation of the revised Standard are given below:
  - A. Licensees:
    - (i) All licensees shall implement the revised Standard by 25 April 2019.BOs shall ensure that no licences are under operation as per the old Standard after 25 April 2019.
    - (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of additional facilitiesmay be done during the next visit.
    - (iii) If the Licensee fails to complete all actions by 25 April 2019 shall be dealt with as per the prevailing guidelines.

- B. Applications for Grant of Licence:
  - (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to the effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised Standard, Licence will not be granted as per the old version.
  - (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 25 March 2019 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 25 April 2019.
  - (iii) Beyond 25 April 2019 licence shall be granted as per the old standard.
- C. Change in Scope of Licence:
  - (i) For change in scope of licence, the relevant provisions as given for Applicants shall apply.
  - (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or up to 25 April 2019, whichever is earlier.
- 7. The above guidelines come into force with immediate effect.
