
While granting licence for All India First applications, many discrepancies have been observed by the undersigned with respect to processing the applications by BOs. The discrepancies are broadly classified as under:

1. Compatibility of IS for Product Certification;
2. Extant Version of Cross-referred Standards;
3. Completeness of test methods and referred standards therein;
4. Availability of complete test facilities for the product (independent/in-house laboratory)

It is therefore decided that before recording applications for All India First cases, BOs under the region may forward the dully filled in checklist to concerned DDGR for obtaining concurrence on recording the applications (copy enclosed).
