Subject: Intimation to DIPP about status of BIS applications where licence was granted/not granted vis-à-vis Cement Desk ad-hoc permission.

This has reference to the subject mentioned above.

While communicating grant of ad-hoc permission to cement manufacturers, DIPP has been requesting BIS to inform them the status of such applications as and when BIS approval for GOL is given to the Cement applicants or when the application is rejected. In this regard, all BOs were earlier advised by CMD-III vide note dated 25/01/2017 and 31/03/2017 that as and when licence is granted by BIS or application rejected due to any reason, a copy of that communication may be sent to DIPP without fail.

Now in a letter addressed to DG, BIS, DIPP has informed that such feedback is not being received from BIS whether cement applicants have been issued with BIS licence or their application have been rejected. In the absence of such feedback from BIS, DIPP finds it difficult to monitor ad-hoc permission issued by them and has again requested BIS to update them with the status of grant of licence or rejection of application.

In view of the above, all BOs are once again requested that whenever a licence is granted to a cement manufacturer or their application rejected/closed, a copy of such letter issued to the applicant shall also be sent to DIPP without fail.

All DDGRs are also requested to ensure that the BOs comply with the above.
