# Subject: Guidelines for implementation of Amendment No. 04 to IS 2202 (Part 1):1999 'Wooden flush door shutters (Solid core type) - Plywood face panels'.

- 1. Amendment No. 4 to IS 2202 (Part 1) : 1999 has been published. The last date for implementation of the amendment is 15 February 2018.
- 2. All BOs shall inform the Applicants/Licensees under their jurisdiction about implementation of the above amendment.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

6.8	Reference to revised IS 12406 : 2003 is incorporated and grade of MDF
	permitted to be used is re-designated as per revised ISS i.e. Grade 1 (SBG-I)

- 4. Consequent upon issuance of the amendment, existing STI has been revised as Doc: STI/2202 (Part 1)/12, December 2017.
- 5. The following are the major changes in the revised STI:
  - 1. Reference to IS 12406 : 2003 and grade 1 (SBG-I) is been included as per Amendment No. 4 to IS 2202 (Part 1):1999
- 6. The guidelines for implementation of the amendment is given below:

#### A. For Licensees:

- (i) All Licensees shall implement the amendment by 15/02/2018. BOs shall ensure that no Licences are under operation as per IS 2202 (Part 1):1999 without Amendment No. 4 after 15/02/2018.
- (ii) Licensees shall confirm conformance to the additional requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) BO may issue endorsement for the revised STI after receipt of STI Acceptance and the confirmation from the Licensee on implementation of the amendment. If the Licensee fails to complete all actions by 15/02/2018 it shall be dealt with as per OMPC.

# **B.** For Applicants:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 15/02/2018 and for such cases Applicant shall give a declaration that they will implement the amendment by 15/02/2018.
- (iii) Beyond 15/02/2018 no Licence shall be granted without consideration of the amendment.

## **C. For Inclusions:**

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 15/02/2018 whichever is earlier.
- 7. The above guidelines come into force with immediate effect.
