Subject: Guidelines for implementation of Amendment No. 02 to IS 2713 (Part 1 to 3) : 1980 'Tubular steel poles for overhead power lines'.

- 1. Amendment No. 02 to IS 2713 (Part 1 to 3): 1980 has been published. The last date for implementation of the amendment is 01 November 2018.
- 2. All BOs shall inform the Applicants/Licensees under their jurisdiction about implementation of the above amendment.
- 3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

- 4. Consequent upon issuance of the amendment, existing STI has been revised as SIT Doc: SIT/IS 2713 (Part 1 to 3)/1, August 2018.
- 5. The guidelines for implementation of the amendment is given below:

A. For Licensees:

- (i) All Licensees shall implement the amendment by 01 November 2018. BOs shall ensure that no Licences are under operation without the amendment after 01 November 2018.
- (ii) Licensees shall confirm conformance for implementation of amendment. If licence covers varieties as per IS 2713 (Part 3), these varieties shall be deleted from scope of the licence and endorsement for revised scope shall be issued.
- (iii) In case of non-implementation of the amendment by 01 November 2018, necessary actions may be initiated.

B. For Applicants:

(i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

- (ii) Applications, which are recorded henceforth, may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only upto 01 November 2018 and for such cases Applicant shall give a declaration that they will implement the amendment by 01 November 2018.
- (iii) Beyond 01 November 2018 no Licence shall be granted without consideration of the amendment.

C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 01 November 2018 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
