Subject: Guidelines for implementation of IS 2418 (Part 1):2018 and IS 2418(Part 2):2018 Tubular Fluorescent Lamps for General Lighting Service

1. IS 2418 (Part 1):1977 covers the requirements and tests and IS 2418 (Part 2):1977 comprises lamp data sheets of Tubular Fluorescent Lamps for General Lighting Service.
2. IS 2418 (Part 1):1977 and IS 2418 (Part 2):1977 has been revised. Consequent upon the revision, IS 2418 (Part 1): 2018 specifies the safety requirements and IS 2418 (Part 2): 2018 specifies the performance requirements and tests including standard lamp data sheets for Tubular Fluorescent Lamps for General Lighting Service. Further, a lamp on which compliance to IS 2418 (Part 2): 2018 is claimed shall comply with the safety requirements of IS 2418 (Part 1): 2018 as well.
3. Considering the above, existing STI for IS 2418 (Part 1):1977 has been revised as Doc: SIT/IS 2418 **(Part 2)**/1/ August 2018.
4. The last date for implementation of the revised Standards is 1st July 2019 after which the old Standards shall stand withdrawn.
5. All BOs shall inform the Applicants and Licensees under their jurisdiction about the revised Standards.
6. The guidelines for implementation of the revised Standard is given below:

A. For Licensees:

- (i) All Licensees operating as per IS 2418 (Part 1):1977 shall switchover to the revised Standard, i.e. IS 2418 (Part 2):2018, by 1st July 2019. BOs shall ensure that no Licences are under operation as per the old Standard after 1st July, 2019.
- (ii) Licensees shall confirm conformance to the additional/modified requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) In case of non-implementation of the revised Standard by 1st July 2019, necessary actions may be initiated.

B. For Applicants:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a

declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per old Standard shall be permitted only upto 1st July 2019 and for such cases Applicant shall give a declaration that they will switchover to revised Standards by 1st July 2019.
- (iii) Beyond 1st July 2019 no Licence shall be granted as per the old Standard.

C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
 - (ii) However, processing of Inclusions as per the old Standard shall be permitted only upto the date of switchover to the revised Standard or upto 1st July 2019 whichever is earlier.
7. The above guidelines come into force with immediate effect.
