References were received from Hon'ble M.P (Lok Sabha), DIPP and meeting got convened by Shri Vijay Pingale, P.S. to Hon'ble Commerce & Industry Minister on 13/04/2018 at Ministry of Commerce and Industry, Udyog Bhavan, New Delhi on the subject matter.

After deliberations, it has been decided that henceforth, the approval for the multiple manufacturing units for welded LPG cylinders (Unit-I, Unit-II, Unit-III etc.) in one premises and in the name of same manufacturer shall not be issued. However. the expansion of the existing unit in the same name in the same premises may be considered for the approved manufacturer of the LPG cylinders.

All the concerned officers are hereby requested that henceforth the permission for manufacturing of welded LPG cylinders shall not be issued to multiple units in one premises and in the name of one manufacturer.

It was also decided in the meeting that Circle and Sub-circle offices shall carry out surprise inspections of the welded LPG cylinders manufacturing units coming under their jurisdiction intermittently to have monitoring of any malpractices.

Manufacturing of welded LPG cylinders in multiple units in one premises in Sub: the name of one manufacturer.

This has reference to the DO letter dated 12/03/2018 from Shri Prem Singh Chandumajra, Hon'ble MP (Lok Sabha) addressed to Shri Suresh Prabhu, Hon'ble Minister for Commerce and Industry, Govt. of India, Ministry of Commerce and Industry, Udyog Bhavan, New Delhi received through DIPP's email dated 09/04/2018 raising the issue of multiple units in single compound or plot of land.

It has been mentioned in the said letter that the permission granted by PESO for manufacture of LPG cylinders in the multiple units in single compound or plot of the land are being misused by some manufacturers. The provision is misused by some of the manufacturers to manufacture cylinders of one plant in another plant located in the same compound. Though there is no irregularity in granting of manufacturing permissions by PESO, it has been requested in the said letter that there is an urgent need to take immediate stern measures with regard to such LPG cylinder manufacturing units which are located in the single premises.

Considering the above facts, it has been decided that henceforth, the approval for the multiple manufacturing units for welded LPG cylinders (Unit-I, Unit-II, Unit-III etc.) in one premises and in the name of same manufacturer shall not be issued. However, the expansion of the existing unit in the same name in the same premises may be considered for the approved manufacturer of the LPG cylinders.

All the concerned officers are hereby requested that henceforth the permission for manufacturing of welded LPG cylinders shall not be issued to multiple units in one premises and in the name of one manufacturer.

It is also decided that Circle and Sub-circle offices shall carry out surprise inspections of the welded LPG cylinders manufacturing units coming under their jurisdiction intermittently to have monitoring of any malpractices.

PESO will convene a meeting with the existing manufacturers of welded LPG cylinders and necessary action will be taken for amalgamation of multiple units in one premises in the name of one manufacturer, after deliberations with the stakeholders.
