Subject: Guidelines for implementation of Amendment No. 10 to IS 4250 : 1980 Specification For Domestic Electrical Food Mixers (Liquidizers & Grinders) And Centrifugal Juicers

- 1. Amendment No. 10 to IS 4250: 1980 has been finalized for implementation with immediate effect.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **immediately**.
- 3. This amendment keeps in abeyance the provisions of Cl 18 and Cl 22.6 of IS 4250: 1980.
- 4. Consequent upon issuance of the amendment, existing Product Manual has been revised as Doc: PM/ IS 4250/ 2/ July 2019.
- 5. The guidelines for implementation of the amendment is given below:

A. <u>LICENSEES</u>:

(i) **Operative Licences**:

- a. For Licences granted based on Option 2 (simplified procedure), the TR of the verification sample shall be evaluated considering Amendment 10. If TR received is partial, appropriate action shall be taken in accordance with guidelines issued by CMD-I.
- b. For other Licences also where any sample has been drawn, the TR shall be evaluated considering Amendment 10.

(ii) Licences granted as per Option 2 (Simplified procedure) under Suspension / under consideration for Cancellation due to failure of sample

- a. Where non-compliance to Cl 18 and/ or Cl 22.6 alone has formed the basis for Suspension/ Cancellation proceedings, a factory visit shall be carried out by the BO. During the visit, all routine tests and the tests not reported for the VS/ RM sample shall be carried out in the factory on the counter-sample. ROS may be processed based on satisfactory visit and conformity of the sample in FT.
- b. Wherever RM sample has already been drawn, in such cases also a factory visit shall be carried out by the BO. During the visit, all routine tests and the tests not reported for the VS sample shall be carried out in the factory on the counter-sample. ROS may be processed based on satisfactory visit and conformity of the sample in FT. The case shall be reviewed on receipt of TR and if the sample is found to be non-conforming, the licence may be processed for cancellation. An undertaking to this effect shall be obtained from the Licensee.

(iii) Other Licences under Suspension/ under consideration for Cancellation due to consecutive failure of samples

- a. Where non-compliance to Cl 18 and/ or Cl 22.6 alone has formed the basis for Suspension/ Cancellation proceedings, a factory visit shall be carried out by the BO. During the visit, all possible tests in a day shall be carried out in the factory on a fresh sample. ROS may be processed based on satisfactory visit and conformity of the sample in FT.
- b. Wherever second RM sample has already been drawn on account of failure of first RM sample, in such cases also a factory visit shall be carried out by the BO. During the visit, all possible tests in a day shall be carried out in the factory on a fresh sample. ROS may be processed based on satisfactory visit and conformity of the sample in FT. The case shall be reviewed on receipt of TR and if the sample is found to be non-conforming, the licence may be processed for cancellation. An undertaking to this effect shall be obtained from the Licensee.
- (iv) For all other situations, including those where Suspension has been imposed/ Cancellation proceedings initiated due to any reason other than that at (ii) & (iii) above, appropriate action shall be taken in accordance with guidelines issued by CMD-I.

B. <u>APPLICATIONS FOR GRANT OF LICENCE</u>:

- (i) Existing Applications shall be processed considering Amendment 10. TRs shall be evaluated considering Amendment 10. If TR is partial, the remaining tests along with all routine tests shall be carried out in the factory on the counter sample.
- (ii) Where non-compliance to Cl 18 and/ or Cl 22.6 alone has formed the basis for not processing for grant of Licence, a factory visit shall be carried out by the BO. During the visit, all routine tests and the tests not reported for the Applicant sample shall be carried out in the factory on the counter-sample. The Application may be processed further based on satisfactory visit and conformity of the sample in FT.

Wherever a second sample has already been drawn, in such cases also a factory visit shall be carried out by the BO. During the visit, all routine tests and the tests not reported for the Applicant sample shall be carried out in the factory on the counter-sample. The Application may be processed further based on satisfactory visit and conformity of the sample in FT. The case shall be reviewed on receipt of TR and if the sample is found to be non-conforming, the licence may be processed for cancellation. An undertaking to this effect shall be obtained from the Applicant.

- (iii) Wherever Applications are under consideration for rejection due to non-compliance of samples to Cl 18 and/ or Cl 22.6 alone, in such cases also, a factory visit shall be carried out by the BO. During the visit, all routine tests and the tests not reported for the Applicant sample shall be carried out in the factory on the latest counter-sample. The Application may be processed further based on satisfactory visit and conformity of the sample in FT.
- 6. The above guidelines come into force with immediate effect.
