Subject: STI, Doc: STI/15298 (Part 2)/3, October 2017, for Personal Protective Equipment Part 2 Safety Footwear.

This has reference to revision of IS 15298 (Part 2):2011/ISO 20345:2004 as IS 15298 (Part 2):2016/ISO 20345:2011 vide Gazette Notification S.O. 3616(E) dated 01 December 2016 and Corrigendum dated 29 August 2017 to Gazette Notification dated 01 December 2016. Accordingly, STI/15298 (Part 2)/3 October 2017 was circulated to all ROs/BOs for implementation of revised IS 15298 (Part 2) : 2016 latest by 31st December 2017 vide our note dated 12 10 2017.

Thereafter, number of comments were received from various ROs/BOs regarding clause 5.3.6 “Innocuousness” requirement. The matter was taken up with CHD. CHD informed that the requirement of “Innocuousness” is stipulated in many footwear standards and the concerned Sectional Committee has already taken up this issue and an Indian Standard is being formulated for the list of chemicals which may be found in footwear along with their test methods.

In view of the above, the Competent Authority has agreed to keep the implementation of cl 5.3.6 requirement of “Innocuousness” for certification of Personal Protective Equipment Part 2 Safety Footwear as per IS 15298(part 2): 2016 in abeyance till the Indian Standard for chemical requirement as mentioned above in para 2 is formulated.

All other requirements of the STI document, STI/15298 (Part 2)/3, October 2017 remains the same.
