### **Subject: Actions to be taken in case of First Fill Leakage of LPG Cylinders**

This has reference to Certification of LPG Cylinders as per IS 3196 (Part 1): 2013.

2. The actions to be taken against LPG Cylinder Licensees in case of First Fill Leakage are detailed in DGO (386)/2014 dated 06 June 2014. As per this Order, 'Stop Marking' shall be issued for recurrence of First Fill Leakage after taking corrective actions on the previous First Fill Leakage if the period of recurrence is "during the operative period of one year since grant of Licence or last renewal of Licence".
3. The above period of recurrence was deliberated during the RO/BO meeting held on 24 Jan 2018 and it was decided that Stop Marking shall be issued in all cases where recurrence of First Fill Leakage is "*within one year*" (and not "*during the operative period of one year since grant of licence or last renewal*").
4. All BOs may take note of the above for immediate implementation.
