'Precast Concrete Blocks for Paving'**

1. Guidelines for implementation of Amendment No 3 to IS 15658 : 2006 'Precast Concrete Blocks for Paving' was circulated vide CMD-III circular ref: CMD-III/16:15658 dated 24/09/2018 with last date for implementation as 28 February 2019.
2. In view of the representations received from various stake holders for extension of date of implementation of amendment no. 3 to IS 15658 : 2006, the matter was reviewed and it has been decided to extend the date of implementation of amendment no. 3 to IS 15658 : 2006 upto 30 September 2019. Other terms and conditions of CMD-III circular ref: CMD-III/16:15658-dated 24/09/2018 remains unchanged.
3. In this regard, it may also be noted that amendment no. 4 to IS 15658 : 2006 has been finalized by CED for editorial changes in the Standard including correction in least count of testing equipment for tensile splitting strength from 0.01 N to 0.01 KN and is under process for gazette notification.
4. All BOs are requested to inform the revised date of implementation including the proposed amendment no. 4 to all Licensees/Applicants immediately and ensure implementation of amendment no. 3 to IS 15658 : 2006 by 30 September 2019 as no further extension may be possible further.
