This document has following salient features which may require specific attention for your valuable comments:

1) As material grades conforming to IS 6911 and IS 15997 have been permitted in this amendment, so requirements for the welding procedure, staining test, and migration of heavy materials have been made mandatory. Apart from the importance of corrosion resistance, following requirements have been also added: a) Sensory verification analysis to ensure no discernible sensory alterations. b) Constituent migration assessment to verify compliance with safe transfer levels. c) Corrosion resistance evaluation to confirm maintenance of stainless steels intrinsic anti-corrosion properties.

Please examine the document and share your comments regarding further improvement in the document.
