1) *In this standard an attempt has been made to cover the terms which are especially applicable to stacking, loading and reclaiming equipment, Terms covering components such as systems, electrical equipment (motors, cables, switch gear, etc.) and general engineering terms relating to bearings, structure, etc, have been left out. Users of this standard are advised to refer to related standards, where applicable, covering the corresponding terminologies. This standard (Part 2) is one of the standards from the series of standards on glossary of terms relating to bulk handling equipment. The glossary of terms relating to cyclic loose bulk handling equipment (non-stationary) is given in IS 10463 (Part 6) and those of equipments for unloading, hydraulic conveying, pneumatic conveying and stationary-cyclic loose bulk handling are proposed to be covered subsequently.*
