1) *This code is intended as a guide to electroplaters to obtain electro- deposited coatings of silver for general engineering purposes. However, any alternative process may be used provided the coating obtained by the method satisfies the requirements specified in the relevant Indian Standard on silver plating. This revision has been brought out to bring the standard in the latest style and format of the Indian Standards. In addition to this, following modifications have been made: a) References clause has been added. b) Requirements for stress relief before plating and heat treatment after plating have been modified.*
