This document has following salient features which may require specific attention for your valuable comments:

- 1) This standard prescribes the requirements, sampling procedure and test methods for automotive diesel fuel (earlier also known as High Speed Diesel Fuel, HSD). It is applicable to automotive diesel fuel for use in diesel engine vehicles and stationary diesel engines, designed to run on automotive diesel fuel.*
- 2) In this seventh revision, requirement for Bharat stage IV (BS IV) automotive diesel fuel have been deleted from Table 1. Also, content of Amendment No. 1 issued in September, 2018 has been incorporated in this revision.*

Please examine the document and share your comments regarding further improvement in the document.
