1) This document supersedes earlier Wide Circulated Doc No. PCD 18 (14314). Following comments have been incorporated in the earlier Wide Circulated draft: i) Need/importance of the standard incorporated in the foreword of the draft; ii) Grade of Hexane (from Chromatographic quality to Chromatographic grade solvent), and carrier flow of Helium incorporated; iii) Recording of the RT in clause 4.3.2 also modified; and iv) Sentence "This method would be useful in conforming presence of adulteration like vegetable oil if any unusual peak is observed" included by BIS Secretariat in the foreword.

Please examine the document and share your comments regarding further improvement in the document.
